## Keynote speaker



**Marcin Kacperczyk** is a Professor of Finance at the Imperial College London Business School. He is also a Research Fellow at the Centre for Economic Policy and Research. In addition, he is a Managing Editor at the *Review of Finance* and serves as an Associate Editor of *Journal of Financial and Quantitative Analysis*. His research focuses mostly on climate finance, financial markets, financial intermediation, and asset management. His articles have appeared in *Econometrica*, *Journal of Finance*, *Journal of Financial Economics*, *Quarterly Journal of Economics*, *Review of Economic Studies*, *Review of Finance* and *Review of Financial Studies*. He is a past holder of two highly prestigious research grants: European Research Council Consolidator Grant and Marie Curie Integration Grant. He is also a past President of the European Finance Association. Before joining Imperial College in

2013, he has been previously appointed at the University of British Columbia Sauder School of Business and New York University Stern School of Business. He obtained a Ph.D. in finance from the Ross School of Business at the University of Michigan.
